CoqWA will evaluate the responses to competitive request for bids (RFB) using the scoring system described below to identify the Contractor(s) considered to be of best overall value and most likely to succeed in a strong, cost-effective, productive working relationship with CoqWA. The successful Contractor(s) will be the one that possesses the skills necessary for the services described in the RFB and offers a cohesive team with recent experience on similar projects.

Bid Evaluation Committee

The committee will consist of at least 3 individuals that may include the CoqWA Riparian Project Manager, CoqWA Restoration Program Coordinator, and ODFW fish biologist. Other committee members may include private landowners involved in this project, other CoqWA program staff, or other technical partners. Bid evaluation committee members will write in justification for points in each section where appropriate.

Award Notice

CoqWA reserves the right, at its sole discretion, to reject any responses received and cancel this RFB. After reviewing the bid evaluation scores and further discussion amongst the bid evaluation committee, the contractor who best fits the project's needs in combination with the highest-ranking score will be given a tentative award. CoqWA and the selected contractor will enter into contract negotiations. Contract negotiations will be directed towards obtaining written agreement on the Contractor's tasks, staffing, performance schedule, and a maximum, not-to-exceed price, which is consistent with the Contractor's bid proposal, and fair and reasonable to CoqWA, taking into account the estimated value, scope, complexity and nature of the services.
